- f) To endeavour that a local competition takes place in Namibia least once a year with the emphasis on the intermediate sector of our trade, thus promoting and assisting the future of our industry.
- g) To name a National Team to compete abroad and carry our national flag abroad, and to promote local products in competition dishes exhibits abroad.
- h) Foster a positive relationship between all Food and Catering colleagues.
- i) The Association will not involve itself in Union/Wage disputes or political matters.
- j) The Association will be a not for profit organization.

CORPORATE/COMPANY/BUSINESS/RESTAURANTS MEMBERSHIP

Corporate Membership for Suppliers is open to suppliers of goods and services within the catering sector as well as any other businesses interested in joining the NamChefs.

The purpose of this Corporate Membership category is to bring suppliers and service providers into contact with both members of and the Association itself, to the mutual benefit of members and suppliers / providers.

Corporate Members of this category are encouraged to make use of the NamChefs logo for their stationary and all other marketing material.

This category of membership includes three (3) individual memberships for the following categories of persons in their employ:

General Managers or Directors

Food & Beverage / Sales Managers

Head-chefs or other involved staff

Additional memberships for further chefs or involved employees comes at a discounted membership fee.

INDIVIDUAL ADDITIONAL MEMBERSHIP FOR CORPORATES/COMPANY/BUSINESS

Individual Additional Membership is targeted for employees of the company being a corporate member of the Namibian Chefs Association for the duration of employment.

Individual Additional Members have NO voting rights.

INDIVIDUAL MEMBERSHIP

Individual Membership is targeted for practising and former chefs, Hotel School graduates, persons directly involved in the hotel, catering or the hospitality industry.

Individual Members should hold a position of responsibility within the industry, followed a recognized training course or been a junior member for 3 years.

Individual Members enjoy full voting rights.

Individual Members are entitled to use the de-signatory letters NamChefs as main corporate membership of the Association.

JUNIOR MEMBERSHIP

Junior membership is designated for newcomers and trainees in the industry, members of the Defence Force Juniors and members whose careers are based on practical rather than academic or structured foundations.

Junior membership available only to an individual for a maximum of three years, after which the individual is advised to apply for individual membership.

Junior members are entitled to use de-signatory letters NamChefs and enjoy full voting rights.

CORPORATE MEMBERSHIP for TRAINING INSTITUTIONS

Corporate Membership for Training Institutions is open to all training suppliers in the Hospitality Sector.

The purpose of this Corporate Membership category is to bring service providers into contact with both members of and the Association itself, to the mutual benefit of members and service providers.

Corporate Members of this category are encouraged to make use of the NamChefs logo for their stationary and all other marketing material.

This category of membership includes two (2) individual memberships for persons in their employ.

Additional memberships for students following courses / training at the institution comes at a discounted membership fee.

SUPPORTING MEMBERSHIP – CORPORATES/BUSINESS OR INDIVIDUALS

SUPPORTING Membership is open to any private person, partnership, company or other association of persons, that is interested in the Aims and Objectives of the NamChefs and is not engaged in the Industry;

This category of membership includes one (1) individual memberships for a person in their employ. A member has one (1) vote.

Additional memberships for employees at the entity comes at a discounted membership fee, valid for the duration of their employment at the entity.
